



The Green Leadership Initiative is a clear marker of how well organizations manage their ESG responsibilities—and why it's now a strategic, not just moral, business priority.



- Lower risk, superior returns
- Globally, ESG leaders delivered 12.9% annual returns, compared to 8.6% for laggards—an almost 50% performance premium. The Global 100 Index of the world's most sustainable corporations achieved a 331% return, outperforming the 279% return of the MSCI All Country World Index.
- Boosts investor confidence
- **91% of impact investors** report meeting or exceeding financial expectations through ESG investments The global impact investing market now **exceeds \$1.57 trillion**, growing at 21% CAGR since 2019.
- Relevance in times of crisis
- ESG portfolios show stronger resilience during market volatility, outperforming traditional equities, while negative ESG events can cause an immediate **0.29% drop in returns**, underscoring the financial value of proactive ESG risk management.
- Regulatory compliances
- Stricter ESG regulations and evolving disclosure norms are accelerating adoption 90% of S&P 500 and 70% of Russell 1000 companies now publish ESG reports. At the same time, ESG-focused investments are projected to surge to \$33.9 trillion by 2026, representing 21% of global AUM, underscoring its strategic importance for capital access and competitiveness


